Technical requirements. PDF is the preferred format for all ads. Other formats, and images embedded in original files, must be at least 300 dpi resolution. Also note:

- Ads must be in final print size. Cover ads with bleeds allow 1/8 inch all sides.
- Fonts must be embedded in file or outlined.
- Colors must be CMYK.
- Before creating PDF, check ads for press readiness by using pre-flight software.
- When exporting to or saving as PDF, use "PDF/X-1a" or "Press Quality" settings.

Production services. Ads requiring typesetting or other production work are subject to additional charges.
